### **TITLE VI OF THE CIVIL RIGHTS ACT OF 1964 NONDISCRIMINATION POLICY STATEMENT**

It is the policy of the Alaska Department of Transportation and Public Facilities (ADOT&PF), in accordance with 49 CFR Part 21 (Department of Transportation Regulations for the Implementation of Title VI of the Civil Rights Act of 1964 and the Civil Rights Restoration Act of 1987 (P.L. 100.259)m and 23 CFR Part 200 (Title VI Program and Related Statutes-Implementation and Review Procedures, Executive Order 12250, 23 USC 324 (Prohibition of Discrimination on the Basis of Sex), Title VIII of the Civil Rights Act of 1964m 23 USC 109(h), DOT Order 1050.2, the Civil Rights Restoration Act of 1987m and Executive Order 12898-Environmental Justice, that no person in the State of Alaska shall, on the grounds of race, color, sex, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity regardless of whether the Department receives federal assistance from the US Department of Transportation, including the Federal Highway Administration (FHWA), the Federal Transit Administration (FTA), and the Federal Aviation Administration (FAA).
