DBE Goal Methodology

The Alaska Department of Transportation & Public Facilities (DOT&PF) proposes an overall DBE goal of 8.83% for FHWA-assisted contracts for federal fiscal years (FFY) 2018 - 2020. The overall DBE goal is based on the relative availability of DBEs to perform work on FHWA-assisted contracts, and represents the level of DBE participation that the department expects, absent the effects of discrimination. To establish the overall DBE goal, the department followed the process detailed in 49 CFR Part 26, which includes establishing a base figure for the relative availability of DBEs, adjusting the base figure to account for evidence pertaining to DBE availability, and determining the race-conscious and race-neutral portions of the goal. In calculating the race-conscious and race-neutral split DOT&PF relied primarily on the 2014 DOT&PF Disparity Study, which recommends an entirely race-neutral DBE program for FHWA. Program Update: American Disabilities with ACT (ADA) Program

The Statewide ADA/Title VI Program Coordinator - Civil Rights personnel have been at the airport ensuring compliance for the Federal Aviation Administration Title VI/ADA. Areas at the airport that have been reviewed are public access, signage, ADA Compliance, parking spaces, curb ramps, sidewalks, and telephone access. In order to ensure compliance the CRO team has conducted interviews with Airport management and also completed walkthroughs with one of the Airport Architects. To assist the ADA Compliance Officer the CRO has formed an ADA Committee composed of local businesses that aid personnel with disability, personnel within the CRO office, and community members. Within the ADA Program we have focused on Ted Stevens International Airport, Fairbanks International Airport, and State of Alaska DOT&PF sites to ensure that pedestrians can access facilities that are all currently in compliance with ADA standards.

Quality Assurance Reviews (QARs)

Call 811 Before you Dig

Nationwide, every 6 minutes an underground utility line is damaged because someone decided to dig without first calling 811.

Alaska has one of the highest rates of damage to underground utility lines in the nation - 3 times the national average for damage to natural gas lines.

The U.S. Department of Transportation, Pipeline and Hazardous Materials Safety Administration (PHMSA) wants you to know that if you cause excavation damage to a natural gas or hazardous liquid pipeline in Alaska, you may be subject to federal penalties of up to \$205,638 for each violation for each day the violation continues, with a maximum penalty up to \$2,056,380 for a related series of violations.

Alaska State Law requires excavators to give notice of proposed excavation so facility owners can mark the location of their facilities. This is for your safety, the safety of those around you and to protect the buried infrastructure. Calling 811 does not cost you, the excavator any money.

To avoid enforcement action make sure you do the following Every Dig, Every Time:

- Call Before You Dig
- Wait the required time
- Respect the Marks
- Obey the Tolerance Zone
- Dig Safely

Call 811 before you dig. The service is free. A broken utility line can be very expensive.
