Auke Bay Corridor Reconnaissance Study Public Involvement Plan

In order for public involvement to be effective, it must begin with clearly defined, projectrelated goals that focus on the specific issues to be addressed, the particular kinds of input needed and the "public" that needs to be involved. This document describes the goals of our public involvement plan and the implementation.

Goals:

- Verify the basis for the project
- Establish the legitimacy of our problem solving and decision making process
- Get to know the Potentially Affected Interests (PAI's)
- Identify and understand problems
- Generate alternative solutions
- Articulate and clarify key issues
- Facilitate two-way information exchange
- Primary goal is to obtain community input into and acceptance of our eventual preferred alternative.

<u>1. CAC</u>

The CAC is a valuable information source. We want to hear their ideas, concerns and how they see the issues from a users perspective. This is an advisory group and the Department is the final decision making authority. However, the CAC will have the opportunity to voice their opinions to the Department prior to any decision making.

The committee will have about 15-20 members. USKH will develop a list of potential members and seek DOT&PF approval. USKH and DOT&PF will together contact potential members and ask for their participation and give them information about the first meeting. The committee will meet five times.

2. Public meetings

The purpose of the public meetings is to:

- Provide timely and adequate opportunities for public participation;
- Exchange information with a wide variety of people in the community; and
- Give DOT&PF a chance to monitor community reactions to agency policy, proposals and progress.

The format for the public meetings will be flexible to allow interested parties a chance to attend the public meeting at a time that is convenient for them and in a format of their liking. The public meetings will start at 4:30 p.m. in the afternoon with an open house format. Staff starting at 6:00 p.m will give a half hour presentation. The meeting will again revert to an open house format until the closing time of 8:00 p.m.

3. Introductory Newsletter

The purpose of the newsletter is to introduce the project, solicit public participation, and provide information about our project development process. It is intended to target a broad public beyond those who attend public meetings. It will present how to get involved in the project development process and contact the project development team.

The newsletter will be written in plain English. The newsletter format will be eye catching, interesting and fun. The newsletter will include project contacts, our web site address, and date, time and location of the first public meeting and an explanation on how to get put on our project mailing list. It may include project maps, photos, history, fast facts.

The newsletter will be sent to local government, resource agencies, the media, special interest groups and our mailing list. It will also be sent to the Mendenhall Station, the Auke Bay Station and Rural Routes 15, 19 and 20. Route 15 covers Glacier Highway and out the road. Route 19 covers Fritz Cove Road. Route 20 covers Back Loop Road.

4. Project Mailing List

Individuals and groups on the mailing list will be notified by postcard of upcoming public meetings one week prior to every meeting. Persons may be added or deleted from the list at any time with a request to USKH.

5. Media strategy

The purpose of our media strategy is for DOT&PF take an active role in disseminating information and proactively form our message about our project. DOT&PF will invite reporters to be briefed before each public meeting. Reporters will be provided with indepth background on our project, which will prepare them to analyze our approach and other project issues.

Public service announcements (PSA's) will be prepared for all radio stations to advertise the public meetings. Where possible, DOT&PF staff will record the PSA's in their own voices and personally invite the public to attend meetings.


Two weeks prior to the public meeting, advertisements will be published in the Juneau Empire Sunday and Wednesday editions. Sunday, two days prior, and the day before meeting an advertisement will be run on the local cable television information channel.

Flyers will be posted in public locations along the project corridor by USKH one week prior to the public meeting.

6. Displays

Two sets of displays will be assembled for each public meeting. One set will be used for meetings and one set will be displayed in local public areas. The display set at the meetings will have a supply of sticky notes in order for meeting participants to stick comments on the displays. The traveling set of displays will be set up in the local shopping malls, the University of Alaska Southeast library, the Auke Bay Post Office or Auke Bay Elementary School. The traveling set of displays will have comment forms and contact information if people would like to mail us a comment of contact us personally.


DOT&PF is Studying the Corridor

WHAT?

The Alaska Department of Transportation and Public Facilities (DOT&PF) contracted with Unwin Scheben Korynta Huettl (USKH) to study the Glacier Highway corridor between the Fritz Cove Road intersection and the Auke Bay Ferry Terminal. The purpose of the study is to find ways to provide a safer and more efficient facility for all vehicles, bicyclists and pedestrians in the area.

USKH will collect information, study the area and predict travel patterns 20 years into the future. DOT&PF and USKH will study traffic patterns, accident rates, the natural and human environment, and visit with the public to obtain a picture of what life is like now and what it may look like in the future.


People have been complaining, trouble spots have been identified. DOT&PF's mission is to provide, operate and maintain safe, environmentally sound and reliable transportation systems.

TRAFFIC DATA IN THE STUDY AREA

What is Average Annual Daily Traffic? It is the total volume of vehicles passing a point or traveling on a segment of a road facility, in both directions, during a 24-hour period, averaged over a year. It is usually abbreviated AADT. The graph below presents the vehicle traffic trend over the last eight years.



Since September 2002, the Alaska Department of Transportation and Public Facilities (DOT&PF) and their consultant, USKH, Inc. (USKH), have been studying how to improve Glacier Highway, between Fritz Cove Road and the Auke Bay Ferry Terminal. We formed a Citizen Advisory Committee (CAC) and a Project Steering Committee (PSC) to gather input about existing problems and future needs on Glacier Highway. We inventoried existing conditions and collecting data on the existing traffic, collisions, roadway geometry, and the environment in the area. We presented an existing condition report and the preliminary draft Purpose and Need statement at an April 3, 2003, public meeting. The Purpose and Need statement describes the reasons DOT&PF is pursuing the project and what needs to be accomplished:

PURPOSE

The purpose of the Auke Bay Corridor project is to improve surface transportation along the Glacier Highway corridor, between Fritz Cove Road and the Auke Bay Ferry Terminal. The improvement should provide sufficient capacity to safely handle the traffic demands for a 20-year design life.

NEED

- Improve the safety of identified intersections and segments.
- Improve the substandard geometric design deficiencies along the existing road alignment.
- Provide more reliable, efficient, convenient, and cost effective movement throughout the corridor.
- Enhance non-motorized access on, off and across the corridor.

Using the preliminary Purpose and Need statement as a guide, we developed seven concepts for improving Glacier Highway. USKH refined three alternatives for further consideration by DOT&PF, the CAC and the PSC. From that group, DOT&PF combined elements of two to select the best plan that meets the needs listed above. The preferred alternative includes both short and long-term improvements. DOT&PF recognizes that there are safety issues that need attention soon. However, we also recognize that we need to address capacity issues in the future. We describe the specific features of the preferred alternative below and graphically on the project area map (see inside).


SHORT-TERM

- Construct a roundabout at the Fritz Cove Road, UAS south entrance, and Glacier Highway intersection.
- Use a two-lane section through Auke Bay but add a left turn lane for NOAA lab.
- Construct sidewalks on both sides of Glacier Highway from Fritz Cove Road to the Spaulding Meadows Trail parking lot.
- Construct a roundabout at the Glacier Highway and Back Loop Road intersection
- Correct safety and sight distance deficiencies near the Auke Bay Post Office and at the Stablers Point curves.

Long-Term

- Plan a complete bypass of the Auke Bay community starting at Industrial Blvd., along the east side of Pedersen Hill, crossing Back Loop Road at Goat Hill and conecting to Glacier Highway near Auke Nu Creek.
- Add a connection from the bypass to Back Loop Road at the north UAS access.
- Use a roundabout at the Back Loop Road, north UAS access and bypass connector intersection.
- Add sidewalks to both sides of Back Loop Road from Glacier Highway to the bypass connector and on the bypass connector to the UAS/National Guard Joint Use facility.
- Add a seawalk/multi-use path on the waterside from the Spaulding Meadows Trailhead to the ferry terminal.



What is Average Annual Daily Traffic? I do know that you take your life in your own hands when you bicycle, walk, or drive from Engineers Cut-off to the Auke Bay School when you try to cross or turn off the highway in the area.

All improvements to date appear to speed up automobiles and increase injuries by automobiles through the Auke Bay Corridor and none try to establish alternative routes and remove dangers of the Old Glacier Highway being a major highway. We will be gone during the hearing period so I am sending my notes and letter now.

Response to DOT&PF Questionaire

1. The most serious problem is the very dangerous intersection at Fritz Cove Road and Glacier Highway. A left turn out of Fritz Cove Road toward Auke Bay is particularly difficult because of insufficient visibility and traffic usually in excess of 50 MPH on Glacier Highway. A possible temporary step to ameliorate this problem would be to move the 40 mile speed limit sign back up the hill toward town so that drivers are alerted to begin to reduce speed well before the intersection The sign's current placement doesn't provide sufficient distance to slow down before the intersection (Residents have requested that DOT consider this, and we are told that UAS also made the same request, but no action has been taken.) At times it becomes necessary to make a right turn toward town and turn around in a driveway in order to go to Auke Bay from the Fritz Cove.

Reducing traffic speed might also make it slightly easier for cars entering Glacier Highway from either side This is a frustrating and dangerous operation for drivers, especially when cars waiting on both sides creates a potential conflict for the lanes.

Obviously, this suggestion would have only limited value and could not be considered a solution to the difficulties posed by this intersection but it could offer some temporary relief. In the long run a signal, greater visibility from the direction of town, relocation of the entrances, or other more permanent solutions must be implemented.

- 2. The Fritz Cove Road needs both a marked bicycle lane, and an unpaved walking path, each along one side of the road Since many people are not able to walk or jog on pavement the walking path should NOT be part of a bicycle path. Since many people do walk on the Fritz Cove Road for exercise and recreation a narrow walking path has emerged organically along much of the road. A width of 18," or even less, on the shoulder of the road would meet this need. It would have been very easy to install when the road was resurfaced and could still be accomplished with minimum effort in most locations.
- 3 We do not believe that either the corridor study or Borough population projections justify major highway relocation or improvements to accommodate future traffic volumes through Auke Bay at the present time.

Making a left turn from Fritz Cove Road onto Glacier Highway is dangerous because of the limited sight distances looking both directions. This needs to be improved.

Straighten out the sharp curve in the area of the National Marine Fisheries Service (NMFS) Auke Bay Laboratory (ABL), and the University of Alaska Southeast (UAS) Andersen Building. Add a turn lane from the outbound direction for access to these facilities. And provide an overpass over the highway for pedestrians and bicycles from the UAS Andersen Building/NMFS ABL area to the UAS main campus and the sidewalks.

Another area of concern is the development between Indian Point and Stablers Point. This is currently a 50 MPH stretch of highway. I fear it will become a 35 MPH zone in the not too distant with the current pace of development. Is there a way to limit the access points in this area?


